

Keyrock Investment Ideas Exchange Day 2021

Period: Submissions end at 9:00 P.M. HKT on 28th May 2021. The Ideas Day will be held on the 19th of June.

Activity & purpose: The purpose of the Keyrock Investment Ideas Exchange Day ("Ideas Day") is to foster and nurture the next generation of aspiring investors in Hong Kong. Selected students will have an opportunity to present (virtually) his/her investment idea at the Ideas Day and receive feedback from a distinguished panel of professional investors. Participants will vote to select the most compelling investment opportunity and the winner will be prioritised for an internship opportunity at Keyrock in 2021. This will be a great opportunity to network with HK-based professional investors, refine and improve your investment pitch and learn what a job in the investment management industry is like.

Guideline: The criteria for investment ideas will be publicly-traded shares of a company that has a market capitalization of at least half a billion USD (\$500,000,000) listed in Asia. An entry must provide an analysis of the security and must be no longer than four (4) pages in length.

What are we looking for?

- Analysis of the business model. What is the business quality?
- How large is the addressable market?
- How is the management quality?
- What is the company's competitive positioning?
- Why is a position in the security a good investment?

Selection process:

- A maximum of ten (10) finalists will be selected by the panel of judges to present at the Ideas Day
- A winner will be selected from the finalists through voting by participants at the Ideas Day,
 who will be prioritised for an internship opportunity at Keyrock in 2021

Eligibility: The Contest is open to current students of any level at the University of Hong Kong, The Chinese University of Hong Kong, The Hong Kong Polytechnic University, City University of Hong Kong, The Hong Kong University of Science and Technology and Hong Kong Baptist University.
