Learning Scheme

Training Workshops

Each member will form a team of 4 where they will be given real-past case samples to present on during the training workshops, providing a handson learning opportunity for the members.

Mentorship Program

Each member will be assigned to an experienced mentor that best fits their interest and role in the team. The mentor will play an integral role in providing guidance for their HICS career.

Collaborative Learning

Joint workshops are organized with other HKU Business School organizations. These efforts are aimed to foster a collaborative learning experience with students beyond HICS.

Competitions

To test the competitive spirit of the teams, internal case competitions are held each semester. Excelling teams are invited to compete in local and international case competitions to represent HKU.

Internal Case Competition

Case competition held in each semester where 12 teams (48 members) formed within HICS compete against one another.

Joint University Case Competition

4 teams that perform well during Internal Case Competitions will be invited to represent HKU in the Joint University Case Competition against other Universities in Hong Kong.

International Case Competitions


Teams that has shown stellar results may be selected to compete abroad in International Case Competitions.




